

## Children and Youth Residential Services Review Questionnaire

The creation of the Ministry of Children and Youth Services (MCYS) in fall 2003 has provided an opportunity to bring together policy and programs addressing child welfare, youth justice, children and youth mental health and services for children and youth with complex / multiple special needs. Over the past two years, the underlying importance of residential services across the children and youth service system has been identified in a number of different contexts. Therefore, it was felt to be timely to review the residential services available for children and youth with a variety of different needs.

The ministry has engaged Bay Consulting Group to undertake a review of residential services for children and youth across a number of sectors, including child welfare, children and youth mental health, children and youth with complex / multiple special needs and developmental services and youth justice. The review will include an examination of existing services, needs, strengths and weaknesses of the current system (including best practices), and a literature and jurisdictional review. Findings of the review will provide a foundation for the development of future policy and service directions. Bay Consulting Group will be collecting information through a number of different sources, including existing information systems, key informant interviews, focus groups with children and families, field visits, and this questionnaire.

This brief questionnaire is intended to solicit your views about children's residential services. We ask that as a key informant you take a few minutes and provide us with your opinions and suggestions. Your responses will be dealt with in confidence by Bay and will be used to guide and inform the review process.

Within the child welfare sector, CAS's need to hold the CASE but allow the resource to do the work. There is a great deal of unnecessary intervention and mixed messages which create issues for clients and families.

 -All resources should belong to an Association  
 -MCYS – clear standards and guidelines in respect to licensing new resources

-Resources should be mandated across province in respect to the “need”  
 -Registry of Resources e.g. “IRIS”  
 -All resources should belong to an association that assist them, monitors them along with standards e.g. accreditation

- Third party accreditation to be mandatory  
 - Evidence based outcomes as a result of a central software program  
 - Enhanced finding for staff and staff training

- Programming** (e.g. issues around age and gender specific services, educational programming, cultural appropriateness, transitions, meeting multiple complex special needs)

-Inventory of resources available – Regionally  
 -Registry – inventory of resources and “needs”  
 -Enhanced funding for educational funding e.g. Day Treatment

-All resources should be financially transparent  
 -Rate set to services provided e.g. “levels of care across the province”  
 -Standardize “Service Agreement” to be used between all resources and referring agents

-All resources to practice best business practices and demonstrate sustainability

**PART E – Other Comments**

Please provide any other comments that you believe are relevant to this review of children and youth residential services.

We feel the province should have one residential care service geared to a fee for service rate that includes a central administrative fee that's not subject to occupancy. It is vital that the Ministry or an assigned third party agency be responsible for direct funding. Child welfare would refer but are not responsible for maintaining and/or supervising. This allows for direct funding credibility which often becomes clouded in CAS's budgets. As well child welfare has established a fair number of "Children's Services Workers" responsible for supervising resources. In actuality they do little to enhance the service or the well-being of the child. As it is considerable time and energy, man hours are lost in meetings, clarifying roles, etc... A third party finding agency or MCYS combined with third party accreditation would do the same while providing evidence based outcomes.
